#### Covid update

We have seen Covid numbers settle a little this week, but they remain high, especially in Years 7 and 8. We are asking students in those years to LFT every day until further notice and to wear face coverings in communal areas.

We are also experiencing a number of students asking to take a test in school because they have not taken one at home. Please ensure that your child(ren) take a test twice a week (unless asked to test daily) and to ensure that the result is known before setting off for school.

Thank you for your continued efforts on this so that disruption to education can be kept to a minimum. This has enabled our attendance rate to remain higher than the national average at almost all points during the year to date.
