Women in the medieval world played a number of different roles.


Women were able to run their own business. inherit property and through devotion to the Church pursue art, poetry, writing or medicine.

# **Succession Crisis**



The 'White Ship' sinks on the way to England. William Adelin, son of Henry I and heir to the throne, is killed. A succession crisis

begins.

Henry I names his daughter, Matilda, as

heir to the throne.

Many English Barons were concerned about the idea of a Queen ruling England.

Henry I dies. Many nobles believe Stephen

of Blois should be heir. Stephen sails to England and declares himself King Stephen I. A Civil War begins, known as The Anarchy.

## **Empress Matilda (Maud):** Known as the 'She-Wolf'. Her first marriage was to

Henry V (Holy Roman Emperor). Maud died in Normandy in 1167.



Stephen of Blois: Empress Matilda's first cousin, initially swore allegiance to Matilda before making his

own claim to the throne.



**Queen Matilda of** Boulogne: Stephen's wife, led military efforts to support his claim to the throne.



Maud captures King Stephen at the Battle of Lincoln. Queen Matilda captures Maud's key ally, Robert of Gloucester in Winchester. Matilda and Maud negotiate a hostage swap.

1143 AD Stephen begins to take castles off the English Barons to support the war effort

## 1148 AD:

The Anarchy: 1139 - 1153

Maud returns to Normandy. Her son, Henry II, has a large army and makes a claim for the throne.

## 1153 AD:

Treaty of Winchester names Henry II as Stephen's heir. Stephen's own heir had died.
